QUALITATIVE ANALYSIS

The Bank's core capital as of 30 June 2021 was IDR 31.1 trillion, an increase compared to the core capital in the previous period. This was mainly due to the increase other disclosed reserves from current year profit.

The Bank's total capital as of 30 June 2021 was IDR 37.6 trillion, a slight increase compared to the total capital in the previous period. This is due to the increase in Tier 1 capital.

Total RWA increased in June 2021 to Rp 137.3 trillion in line with the increase in credit risk RWA. The increase in Total RWA caused the CET1 Ratio, Tier 1 Ratio & Capital Adequacy Ratio to decrease. In June 2021 the Total Capital Ratio was at 27.36%.
